- MEP J [REDACTED] elected in the European Parliament through EH Bildu platform, in Spain.

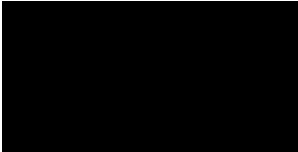
