Our General Assembly in its meeting of 1<sup>st</sup> April 2017 (Katowice) has decided to request recognition as European Political Foundation as per Regulation (EU, EURATOM) No 1141/2014 of the European Parliament and of the Council of 22 October 2014. Please consider this letter as our application for recognition. Enclosed you will find the required supporting documents as required by article 3.2 of the abovementioned regulation to certify the following:

- (a) Centre Maurits Coppieters is affiliated to the European Free Alliance (EUPP 6BE0866.016.691). Please refer to ANNEX I.
- (b) Centre Maurits Coppieters has a seat in a European Union member state. Please refer to ANNEX I.
- (c) Centre Maurits Coppieters observes, in particular in its programme and in its activities, the values on which the Union is founded, as expressed in Article 2 TEU, namely respect for human dignity, freedom, democracy, equality, the rule of law and respect for human rights, including the rights of persons belonging to minorities. - (f) Centre Maurits Coppieters does not pursue profit goals. Please refer to ANNEX I.
